Agreement for Contract for Shared Fire Services between the Valley of the Moon Fire Protection District and the Glen Ellen Fire Protection District

AGREEMENT FOR CONTRACT FOR SHARED FIRE CHIEF SERVICES BETWEEN THE VALLEY OF THE MOON FIRE PROTECTION DISTRICT AND THE GLEN ELLEN FIRE PROTECTION DISTRICT

This Agreement ("AGREEMENT") is entered into as of	, by and
between the Valley of the Moon Fire Protection District ("VOMFPD") and the	e Glen Ellen Fire
Protection District ("GEFPD"), both fire protection districts formed and operation	ted pursuant to the
California Fire Protection District Law of 1987, California Health and Safety O	Code section
13800, et seq. These districts shall be collectively referred to herein as "the pa	arties".

RECITALS

WHEREAS, GEFPD desires to contract for the provision of Fire Chief services on a temporary basis while VOMFPD and GEFPD complete a feasibility study on a coordinated arrangement for providing all-risk fire protection and emergency medical services; and

WHEREAS, VOMFPD is able and willing to provide such contract Fire Chief services; and

WHEREAS, the parties are entering into this AGREEMENT as authorized pursuant to California Government Code section 6502, 6504(d), and 54980, *et seq.*, and

Now, therefore, VOMFPD and GEFPD agree as follows:

- 1. <u>SCOPE OF SERVICES GEFPD FIRE CHIEF</u>. VOMFPD agrees to assign an employee who is a subordinate Chief Officer to GEFPD to fulfill the duties of the GEFPD Fire Chief as set forth below.
- (a) The GEFPD Board of Directors shall have authority to approve the VOMFPD employee who is assigned as the GEFPD Fire Chief and the GEFPD Fire Chief will report directly to the GEFPD Board of Directors.
- (b) The GEFPD Fire Chief will provide general administration and oversight of GEFPD, including, but not limited to, budget administration, personnel management and supervision, training, incident command, and similar related activities, all in accordance with the requirement and expectations of statutory law, applicable GEFPD regulations, and the customary duties of a fire chief.
- (c) GEFPD will make available to the GEFPD Fire Chief, all necessary regulations, policies, procedures, manuals, and other information, as well as incidental materials and supplies, work area, computer access, telephone, and other standard equipment required to perform the Fire Chief services desired by GEFPD under this AGREEMENT.

- 2. <u>TERM OF AGREEMENT</u>. The term of this AGREEMENT shall commence with the assignment of the GEFPD Fire Chief and shall continue for six (6) months. The parties shall have the option to extend this AGREEMENT in three (3) month increments with a written amendment to this AGREEMENT. Either party can terminate this AGREEMENT with thirty (30) days written notice to the other party.
- 3. <u>EMPLOYMENT OF PERSONNEL</u>. For services provided under this AGREEMENT, the GEFPD Fire Chief shall be considered and remain an employee of VOMFPD.
- 4. <u>PAYMENT</u>. For the services provided under this AGREEMENT, GEFPD shall compensate VOMFPD at a monthly rate of \$575.00 per month, payable on the first of each month that this AGREEMENT is in effect.
- 5. <u>INSURANCE AND INDEMNIFICATION</u>. Each party shall continue to maintain its existing liability insurance coverage, and shall name the other party as an additional named insured under such liability insurance policies for the services provided under this AGREEMENT. Furthermore, each party shall mutually indemnify and release the other party from any and all claims arising from the services provided under this AGREMENT.
- 6. <u>SEVERABILITY</u>. If any term or portion of this AGREEMENT is held to be invalid, illegal, or otherwise unenforceable by a court of competent jurisdiction, the remaining provisions of this AGREEMENT shall continue in full force and effect.
- 7. <u>NOT A JOINT VENTURE OR JOINT POWERS AUTHORITY</u>. The parties intend by this AGREEMENT to establish only an agreement for contract Fire Chief services, and do not intend to create a joint venture, joint powers agency, partnership or other joint enterprise of any kind. This AGREEMENT is expressly not a "fire protection contract" as that term is defined in California Government Code section 56134.
- 8. <u>NOTICES</u>. All notices required under this AGREEMENT shall be in writing and mailed postage prepaid to the appropriate address indicated below:

- 9. <u>AMENDMENT MUST BE IN WRITING</u>. No modification, waiver, or amendment to this AGREEMENT is effective unless made in writing and signed by the representatives of both parties.
- 10. <u>GOVERNING LAW</u>. This AGREEMENT shall be governed by and construed to the laws of the State of California. Venue for any action regarding this AGREEMENT shall be in the Superior Court of the County of Sonoma.
- 11. <u>AUTHORITY TO ENTER INTO AGREEMENT</u>. Each party warrants that the individuals who have signed this AGREEMENT have the legal power, right, and authority to make this AGREEMENT and to bind each respective party.
- 12. <u>ENTIRE AGREEMENT</u>. This AGREEMENT constitutes the complete and exclusive statement of the AGREEMENT between the parties for shared Fire Chief services. No terms, conditions, understandings, or agreements purporting to modify or vary this AGREEMENT, unless hereafter made in writing and signed by the representatives of both parties, shall be binding on the parties.
